




WHY CORK

LOCATION

The property is situated in the heart of Cork city centre in a high-profile corner position at the eastern end of South Mall with return frontage to Parnell Place. DESCRIPTION

97 South Mall comprises a nine bay two storey plus attic period building constructed in 1865. It is a Renaissance-revival, Palazzo style former Bank building with a very attractive limestone external façade decorated with columns and elaborate carvings.

Internally the property was extensively refurbished in 2018 to provide modern high specification office accommodation. We understand the property extends to approximately 1,035.9 sq m (11,150 sq ft).

The ground floor comprises reception, open plan office area (former banking hall), training and meeting rooms, canteen with break-out area and restrooms.

A lift and stairs serve the upper floors. The first floor/mezzanine level comprises 2 open plan terrace office areas which overlook the ground floor level, 2 large multi occupancy offices, 3 meeting rooms, tea station, storage rooms and rest rooms. The second floor comprises 2 large multi occupancy offices, 3 meeting rooms, comms room, storage room and restrooms with shower.
