
CRESCENT SHOPPING CENTRE

LOCATION


Crescent Shopping Centre is located on the peripheral of Limerick City Centre and is the largest regional shopping centre outside of Dublin.

Limerick is Ireland's third largest city and the Regional Capital of the mid-western area with a population of 364,028 people. Limerick is one of Ireland's fastest growing cities and a regular target for FDI, with recent commitments of €85m from EIB.

Limerick's 2030 plan ensures continuous investment in the city and a growing, highly skilled and high earning population.









TRANSPORT LINKS

Crescent Shopping Centre is located approximately 3km from Limerick city centre and is serviced by bus routes which have direct links to the city centre and University of Limerick

The centre provides over 2,500 free car parking spaces. Crescent Shopping Centre is easily accessible from key arterial routes such as the N7 and Southern Ring Road. The Southern Ring Road passes directly outside the shopping centre and provides easy access for customers from surrounding areas such as Shannon, Ennis, Tipperary and Cork.

Multiple bus routes connect Crescent to the city and wider population centers. Regular Irish rail services connect Limerick to Cork, Galway, Kerry and Dublin.


