The Location

Located in Kinsale town, with a population of approximately 5,281 people. Kinsale is located approximately 27 km south of Cork city and within a 20-minute drive of Cork International Airport. Description

The property comprises the ground only of a terraced three-storey building, built c.1880. The building has a pitched artificial slate roofs with cast-iron and uPVC gutters and downpipes. Finished with painted rendered walls with molded brick sill courses and painted brick quoins to first and second floor (north elevation).

Internally the property has a public post office to the front mid-section of the ground floor accessed from the public pavement. The sorting office and ancillary uses are to the rear of the Post Office on ground floor. The upper floor contains toilet, shower and kitchen accommodation.
