The Location

Skibbereen, with a population of 2,800 persons approx. is a large market town located in West Cork on the N71 national primary route located 85 kilometers southwest of Cork City Centre. The subject property is located in the heart of Skibbereen at the intersection of Main Street, High Street and Market Street.

Adjoining properties comprise of a mix of commercial and residential uses. Nearby occupiers include a number of retail shops, pubs, restaurants and Bank of Ireland.

Description

Skibbereen Post Office comprises of a gable-fronted three-bay single-storey building, built 1904, with two-bay southwest elevation. It has a pitched artificial slate roof behind round-headed gable parapet with carved limestone coping.

Internally the property has a public post office, sorting office, storage areas, offices, kitchen and staff services.
